Candidates standing for Director. There are 6 board places, and 9 candidates

James Maurici QC I am a barrister at Landmark Chambers. I was called to the Bar of England & Barrister Wales in 1996. I was appointed Queen's Counsel in 2013. Landmark Chambers My practice has encompassed all aspects of compulsory purchase for nearly 25 years. A recent example was acting for Highways England and Walsall Borough Council on the inquiry into the Highways England Company Limited (M6 Junction 10) (Slip Roads, Special Roads) Scheme 2018 and related orders all concerned with highway alterations and improvements at Junction 10 of the M6. I have defended a number of High Court challenges to compulsory purchase orders including the Olympic CPO challenges. I also regularly act in compulsory purchase compensation matters. In addition, I have written and lectured widely on State aid issues in relation to compulsory purchase (see e.g. State aid in planning and compulsory purchase order cases J.P.L. 2015, 6, 621-643) and I regularly advise on these issues. I was until recently the chair of the Planning Practice Group in Landmark Chambers. Between 2008 and 2016 I was on the Council of United Kingdom Environmental Law Association ("UKELA") and was also on the Executive Committee of UKELA for much of that time. I chaired the organizing committee for the annual UKELA conference for 3 years. I thus have considerable experience on working as a board member for professional organisations similar to the CPA. I would like the opportunity to make use of my considerable experience of compulsory purchase and also my experience working in similar professional associations by becoming a CPA Board member.



Abigail Walters Associate Director BCLP



I am an Associate Director with BCLP in London and I specialise in compulsory purchase related work. During the last 20 years I have worked with both Acquiring Authorities and Claimants advising on a range of different projects covering all aspects of the Compulsory Purchase system including compensation. As such, I have a good understanding of some of the difficulties facing both Acquiring Authorities and Claimants operating in our current system and therefore the need for organisations such as the CPA to promote best practice and engage with the Government to ensure fair and appropriate changes to the system.

As a CPA board member for the last two years, and having volunteered on sub-groups prior to that, I am very supportive of the important work of the CPO in promoting best practice, looking at how to change adversarial behaviours and engaging with Government in relation to changes to law and policy. Merle Boyd Director, Rural Savills



My name is Merle Boyd. I am a Director with Savills and I am based in the Perth Office. I sit within the professional team under Rural Energy and Projects and head up the Compulsory Purchase Board within this for Scotland and the UK within Savills.

I qualified from Aberdeen University in 2005 with a Bachelors degree in Land Economy. I worked for Davidson and Robertson Rural where I started my training and my RICS Assessment of Professional Competence (APC) and moved to Savills half way through where I was successful in passing my APC first time round. From the start of my career as a trainee, I was heavily involved in utilities and compulsory purchase work. At Davidson and Robertson Rural, I acted on behalf of Scottish Water and Scottish Gas Networks in negotiating access agreements, implementing statutory notices for access, and compensation claims for water, sewerage and gas schemes. I also assisted in the Lands Tribunal case for Dundas Estate in relation to the M9 Spur extension.

After moving to Savills, I became primarily involved in Estate Management and was responsible for the day to day management of the Wemyss Estate in Fife. This gave me experience not only in traditional management matters but the negotiation of various wind farm deals and opencast coal mines. There was a Scottish Power transmission power line running through one of the opencast coalmine sites and we terminated the Wayleave agreement to be able to work the minerals below the tower. The case ultimately progressed through the Necessary Wayleave process and to public inquiry. At the time Scottish Power were seeking a 40 year Necessary Wayleave yet we were successful in getting a 3 year Wayleave granted. We also claimed compensation for sterilised coal reserves due to the presence of the tower and its stand off distances.

I was involved in various claims in relation to the Beauly Denny power line. I have dealt with objections to the scheme, negotiated access and compensation claims, including injurious affections claims, for its impact on various types of property including farmland, residential properties and sporting estates.

I am currently involved in a number of road schemes in Scotland and England including the dualling of the A9, A66, A1 and A96. My team has been involved from the beginning of these schemes advising clients from the consultation stages through to draft Orders and then the claim stage in due course. I have been involved in the preparation and proceedings of Public Local Inquiries where objections have been sustained for these schemes, providing specialist reports on a number of aspects of the objections.

I would like to stand as a board member in order to raise the profile of compulsory purchase but also to make a difference. Through my work and involvement, particularly through road schemes and acting for affected
